Bullet Point of Discussions:

- 1) MoU has been signed by all parties.
- 2) Discussion on near real-time data pathways lead by JT and LR see action (1)
- 3) Discussion on joint OPEG/OOSIG and UKIMON roles and responsibilities JR will update the Venn diagram and distribute.
- 4) RM and DH gave presentation on the monitoring requirement for MSFD under Article 8 under the rolling 6 year assessments. A trial exercise for temperature and salinity datasets was suggested to test existing delayed-mode pathways see Actions (2) and (3). Defra data strategy to get 8000 datasets published by June 2016 (Open Data Culture).
- 5) EMECO has undergone a refresh to ensure it is robust and resilient.

AOB

- 1) TS suggested that H2020 call on "novel in-situ observing systems" due March 2017 may be a vehicle to consolidate UKIMON. Expression of interest to TS.
- 2) MS reported that AFBINI mooring 38 in Western Irish Sea was continuing and inshore mooring were being upgraded. Joint AFBINI/SAMS/Marine Institute bid for INTERREG funding submitted. This will also support the unfunded Tiree mooring.
- 3) SH enquired if UKIMON included overseas territories.
